**Coming events:**

**Thursday, April 16, 6:30 p.m. Board and membership meeting,** Stark Agricultural Building, MTSU. Stark is near the center of the campus opposite the Business and Aerospace Bldg. Best access is from Rutherford Blvd. on MTSU Blvd. Go through the roundabout and then watch for Stark on the right at the next intersection. Parking should be available at that time of the evening. The meeting is in the downstairs conference room.

**Monday, April 20, 5:30 p.m. Regional Opportunity Forum.** Come discuss the link between local environmental restoration and the global issue of climate change. The session will be held at the Patterson Park Community Center in Murfreesboro. Several speakers will set a framework for group consideration of personal and community actions in the areas of natural infrastructure, clean energy, energy efficiency, water quality and greenways. Another topic of interest will be proposed legislation for creating a "cap and trade" program for setting limits on carbon emissions.
